## **Pending Action Items:**

(Wastewater Topic) - No new Update

## (College Street Bridge) – No New Update

We are still waiting for the State to conduct their final project audit, before we can process the final billing. We hope that we will get anywhere from \$80,000 - \$85,000 back from our retainage. This could bring our remaining project balance to \$250,000 or less. We anticipate paying the balance down with \$100,000 from Road Use tax (which maybe in two payment for cash flow reasons), and we have already declared \$75,000 in Tax Increment Financing Asking's. This could leave us with a balance of approximately \$75,000 which could come from future TIF asking or payment from Water or Sewer funds (since portions of this project involved these infrastructure items). V&K has conducted a walk-through with the contractor and lowa Department of Transportation. If you have any questions, comments, or concerns; please do not hesitate to contact the city's project engineers.

## (Cubby Park) Splash Pad – No new Update

The West Branch Lions Club and Bayer have indicated that they are interested in donating a total of \$5,000 to the West Branch Splash Pad project.



This would bring our total to \$5,048.00. Our goal is \$170,000 for a splash pad that uses recirculates water system. A pass through water system would cost less but would be less environmentally friendly and could hurt the City's ability to expand its water permit as the city continues to grow.

## **Report from the Desk of the City Administrator:**

- Reminder New Councilmembers: Please set up time with Nick for website pictures.
- The Volkswagen Settlement Grants were prepared by volunteers and were submitted by the city yesterday. One for Type 1 Fast DC charging Station for \$75,285; and another one for a Type 2 community charging station for \$14,450. In both cases if awarded a 10% match would be required.

## Follow up / Reminder Items:

Downtown East Redevelopment Site. It has been determined that the city can be reimbursed if the rock
material remains on the site. However we MUST have a third party weighing process that is accepted by
DNR. It was stressed that we need to have tickets that verify the material to be removed. This process will
only account for a potential \$25,000. The other \$25,000 it be expense to the removal of the structures
deconstructed this is to include the concrete foundation and surround structures including drives and
foundations.

- Dollar General Items. The developer is working through couple of items and is waiting to hear from the
  city regarding conditions. After review staff is recommending upholding original stormwater requirements
  and allowing the developer to access the \$10,000 stormwater escrow for this project. The city anticipates
  forgoing the land for exchange for a trail public improvement with the surface up for negotiation. A
  meeting is expected to occur this week. Once these details are worked out the project will be presented
  to planning and zoning.
- Cedar/Johnson County Road Question regarding Speed limit. We have received complaints that the Speed limit traveling south is 35 mph (Johnson County Jurisdiction). Yet, on the east side of the road traveling north the speed limit is 25mph (City of West Branch Jurisdiction). We found a 28e agreement from 1977 that gives the responsibility of all maintenance including erecting and maintenance of signs to the City of West Branch (see: attachment 1). For this reason, I believe we can move forward with changing the speed limit on Cedar Johnson County Road.

# JOHNSON COUNTY-CITY OF WEST BRANCH ROAD MAINTENANCE AGREEMENT



This agreement is entered into pursuant to Chapter 28E of the <u>Code of Iowa</u> by Johnson County, Iowa, a municipal corporation, and the City of West Branch, Iowa, a municipal corporation;

Whereas, the county line road on the border of Johnson and Cedar Counties located on the west edge of Section 6, Township 79 North, Range 4 West and running northerly from Old Highway One for a distance of one-half mile is in need of continous maintenance and repair; and

Whereas, the west one-half of said road is located within

Johnson County and the east one-half of said road is located within

the corporate limits of the City of West Branch; and

Whereas, Johnson County and the City of West Branch mutually agree that maintenance and repair of said road is both beneficial and necessary to the use thereof and both Johnson County and the City of West Branch mutually desire to reach an equitable decision as to future construction, maintenance, and repair of said road;

Now, therefore, in consideration of the mutual covenants and agreements hereinafter set forth, the parties hereto, legally intending to be bound hereby, do covenant and agree for themselves and their respective successors as follows:

The City of West Branch shall at its cost, construct,
 maintain and repair the road situated upon the following described

## real property, to wit:

The Johnson-Cedar County Line Road beginning at the south-west corner of Section 6, Township 79 North, Range 4 West, where Old Highway One intersects the Johnson-Cedar County Line Road, and then north on the county line to the West quarter corner of Section 6, Township 79 North, Range 4 West, a distance of one-half mile.

- Johnson County is hereby relieved of any and all responsibility for construction, maintenance and repair of said road.
- 3. Such construction, maintenance and repair shall include but shall not be limited to the following:
  - A. maintenance resurfacing road rock;
  - → B. dragging of roadway and snow removal;
  - X C. all repairs of bridges and/or culverts;
- N X D. bridge inspection, rating and posting;
  - X E. construction or reconstruction of roadway, bridge and/or culvert;
    - X F. repair of tile lines;
    - ★ G. placement of new tile lines;
  - N H. erection and maintenance of signs;
  - I. driveway repair and culvert replacement;
  - N J. ditch cleaning;
  - K. new driveway construction;
  - N L. dust control;
  - X M. paving or other forms of permanent improvement;
  - N. any and all traffic control procedures and devices.

- 4. In consideration of the City of West Branch's above described agreement to construct, maintain and repair said road, Johnson County shall pay to the City of West Branch the sum of \$2,353.50, which amount shall be payable upon execution of this contract.
- 5. This agreement shall become effective upon execution by the parties and shall continue in perpetuity unless otherwise modified by mutual agreement of the parties.
- 6. This agreement shall be filed with the Secretary of State, State of Iowa, and recorded with the Johnson County Recorder and the Cedar County Recorder in compliance with Chapter 28E Code of Iowa.



- Funding mechanism for LCWMA discussion
  - a. Review formulas
    - Indian Creek- 6 entities: 60% area and 40% value of property in floodway to figure out % each entity should pay.
    - ii. Membership fee.
  - Discuss formulas: Boone River made their coordinator into a full-time position, there are
    positive and negatives either way you go.
  - c. The board decided since we did not have enough information about different formulas we couldn't choose one to adopt for the LCWMA, but the board asks each member to ask their organization what they can do to support the LCWMA for this fiscal year, every contribution is valuable to accomplish our goals.
  - d. The funds that we have raised thus far were the key to us being awarded the WMA Planning grant and will be utilized to accomplish the goals we had initially planned to utilize the funds for.
  - e. Future budget needs: we will need around \$30,000 in match for our \$125,000 hydrologic study for the Lower Cedar watershed if FEMA accepts our application. This could happen in the next 1-2 years. An estimate to provide an appropriate salary for a watershed coordinator would be around \$50,000.

- f. Once the WMA planning grant and hydrologic study are completed the LC watershed will be in a much better position to apply and receive grants for projects. The phrase spend money to get money can be applied in this situation.
- g. Announcement: Holly Howard, Lower Cedar Watershed Coordinator has received a promotion to become a fulltime NRCS Soil Conservationist with benefits and a permanent position, as result she will no longer be able to serve as the watershed coordinator. "I truly have loved doing the watershed work and am committed to the Lower Cedar watershed efforts. I plan on continuing my involvement as a volunteer representative. It will look different, but if we all work together WE can still accomplish the goals we have been aiming for. Also, myself and a few others are actively working on what the plan will be moving forward with the WMA planning Grant."- Holly

**BACKGROUND:** In 2010, Iowa lawmakers passed legislation authorizing the creation of Watershed Management Authorities (Iowa Administrative Code Chapter 466B Subchapter II). A Watershed Management Authority (WMA) is a mechanism for cities, counties, Soil and Water Conservation Districts (SWCDs) and stakeholders to cooperatively engage in planning and management at the watershed scale. A WMA is being formed for the Lower Cedar Watershed including parts of Cedar, Johnson, Jones, Linn, Louisa, Muscatine, and Scott Counties.

A WMA is formed by a Chapter 28E Agreement by two or more eligible political subdivisions within the watershed. A board of directors governs the WMA, which may undertake the following activities:

- Assess and reduce flood risk;
- Assess and improve water quality;
- Monitor federal flood risk planning and activities;
- Educate residents of the watershed regarding flood risks and water quality; and
- Allocate moneys made available to the Authority for purposes of water quality and flood mitigation.

A WMA does not have taxing authority and it may not acquire property through eminent domain.
