West Branch, Iowa Council Chambers City Council Regular Meeting January 3, 2022 7:00 p.m.

Mayor Roger Laughlin called the West Branch City Council regular meeting to order at 7:00 p.m. Roll call: Council members: Jerry Sexton, Jodee Stoolman, Tom Dean and Nick Goodweiler was present. Absent: Colton Miller. City Staff present: City Administrator Adam Kofoed, City Clerk Leslie Brick and City Attorney Kevin Olson and Fire Chief Kevin Stoolman. City Staff attending via Zoom: Public Works Director Matt Goodale, Parks & Recreation Director Melissa Russell, Finance Officer Heidi Van Auken, Library/IT Director Nick Shimmin, Police Chief John Hanna, and City Engineer Dave Schechinger.

PRESENTATIONS / COMMUNICATIONS / OPEN FORUM

Water Tower Maintenance Proposal, Melinda Kurtz, Suez Utility System Consultant – Kurtz explained the program Suez offers to cities which provides ongoing management and maintenance for any thing water related. The presentation included photos on what repairs are needed based on a recent inspection of the towers. Kurtz also provided a maintenance and payment schedule for each tower. Sexton asked staff how maintenance is currently being handled. Goodale said that they do try to perform and schedule some of the maintenance, but it takes time and that his staff doesn't necessarily have the expertise in some of the maintenance needs. Goodale added that the south tower, constructed in 2007 has the original paint and is due for re-painting. The north tower, constructed in the late 70's was last painted in 2007 and cost upwards of \$150,000. Goodale said this maintenance program and payment schedule would keep inspections, maintenance and repairs on a schedule and allow the city to better budget for the program. Laughlin thanked Kurtz for the information and said the Council would consider the proposal during their upcoming budget discussions.

<u>Third Reading Ordinance 786 – Amending Title "Traffic and Vehicles" Chapter 69 "Parking Regulations".</u> / Move to action.

ORDINANCE 786

AN ORDINANCE AMENDING TITLE "TRAFFIC AND VEHICLES" CHAPTER 69 "PARKING REGULATIONS".

WHEREAS, the City of West Branch, lowa has jurisdiction to establish Parking Regulations within the corporate limits of the City of West Branch; and

WHEREAS, No Parking Zones shall mean, so stop, stand, or parking of a vehicle in any of the following designated no parking zones except when necessary to avoid conflict with other traffic or in compliance with the direction of a peace officer or traffic control signal; and WHEREAS, the City Council has heretofore deemed it necessary and desirable to pass legislation regulating the no parking zones within the City.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of West Branch, Cedar County, Iowa:

<u>Section 1: Amendment.</u> The Code of Ordinances is hereby amended by the City Council of West Branch, Iowa by adding the following new subsections to Title, "TRAFFIC AND VEHICLES", Chapter 69, "PARKING REGULATIONS", Section 69.08, NO PARKING ZONES. (Insert after current subsection)

The north side of Elm Street.

(Insert after current subsection)

The south side of Elm Street from its intersection with Parkside Drive to Chestnut Drive (private).

(Insert after current subsection)

Both sides of Sycamore Drive except along the east curb line of Lot 13 Parkside Hills of a portion of Lot D of the NW ¼ SEC.8T.79N.-R.4W.-5P.M.

Renumber all remaining subsections after these changes.

<u>Section 2. Conflicts.</u> All ordinances or parts of ordinances not specifically provided for and in conflict with the provisions of this ordinance are hereby repealed.

<u>Section 3. Adjudication.</u> If any section, provision, or part of this ordinance shall be adjudged to be invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

Section 4. Effective Date. This ordinance shall be in full force and effect after its passage, approval and publication as required by law.

ORDINANCE 787

AN ORDINANCE AMENDING TITLE "TRAFFIC AND VEHICLES" CHAPTER 65 "STOP OR YIELD REQUIRED".

WHEREAS, the West Branch City Council finds it in the best interest of the residents of West Branch to have stop signs installed on Elm Street at its intersection with Parkside Drive, on South 2nd Street at its intersection with Elm Street, on Sycamore Drive at both intersections with Elm Street, on Chestnut Drive (private road) at its intersection with Elm Street, on Hickory Drive (private road) with its intersection of Elm Street and with its intersection of Sycamore Drive in order to provide for the safety of the West Branch Community.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of West Branch, Cedar County, Iowa:

<u>Section 1: Amendment.</u> The Code of Ordinances is hereby amended by the City Council of West Branch, Iowa by adding the following new subsections to Title, "TRAFFIC AND VEHICLES", Chapter 65, "STOP OR YIELD REQUIRED", Section 65.02, STOP REQUIRED. (Insert after current subsection)

The west bound lane of Elm Street to its intersection with Parkside Drive.

(Insert after current subsection)

The south bound lane of South Second Street to its intersection with Elm Street.

(Insert after current subsection)

On Sycamore Drive at both intersections with Elm Street.

(Insert after current subsection)

The north bound lane of Chestnut Drive (private) at its intersection with Elm Street.

(Insert after current subsection)

The north bound lane of Hickory Drive (private) at its intersection with Elm Street.

(Insert after current subsection)

The west bound land of Hickory Drive (private) at its intersection with Sycamore Drive.

Renumber all remaining subsections after these changes.

Section 2. Conflicts. All ordinances or parts of ordinances not specifically provided for and in conflict with the provisions of this ordinance are hereby repealed.

<u>Section 3. Adjudication.</u> If any section, provision, or part of this ordinance shall be adjudged to be invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

Section 4. Effective Date. This ordinance shall be in full force and effect after its passage, approval and publication as required by law.

Resolution 2022-03 - setting strategic goals and priorities for the City of West Branch for 2022 and beyond—. /Move to action.

Sexton asked to discuss recent developments on the Herbert Hoover Highway / Cedar-Johnson Round-a-bout. Schechinger responded and said that Johnson County Supervisors recently found an (old) recorded 28E Agreement between the City of West Branch and Johnson County regarding the future maintenance of Cedar-Johnson Road. He said the agreement, dated in the late 70's was being reviewed by the city attorney to see if

the agreement is still binding. Schechinger said the cost share of the Cedar-Johnson Road portion is now being reconsidered with this new finding and whether or not West Branch will be required to pay for that portion of the project as well. Sexton, clearly frustrated with the project and the constant back and forth on who would pay for what, when and how said it is only increasing the city's engineering costs and may not be worth moving forward. Kofoed added that from the list of goals and priorities, he would be working on a salary survey in February as part of the budget process.

Motion by Dean, second by Goodweiler to approve Resolution 2022-03. AYES: Dean, Goodweiler, Stoolman, Sexton. NAYS: None. Absent: Miller. Motion carried.

<u>Resolution 2202-04 – accepting the I-80 Water Main Relocation, West Branch, Iowa Project as substantially complete.</u> /Move to action.

Motion by Sexton, second by Goodweiler to approve Resolution 2022-04. AYES: Sexton, Goodweiler, Dean, Stoolman. NAYS: None. Absent: Miller. Motion carried.

<u>Discussion – (Draft) Water Fund Budget – birds eye view summary</u>

Kofoed presented a sample budget and what the Council will see at their first FY23 budget work session next week. Kofoed said he plans to present the information in an easy to follow format which will provide current fund balances, anticipated revenues, expenses, transfers in and out and loans payments from those accounts to give the Council a better picture of the health of the fund balances. Kofoed said he is also reviewing staff salaries and how they are currently being budgeted. Kofoed said changes may be needed which will result in the general fund being hit a little harder, but may also allow a little more for projects.

Schechinger said the waste water treatment facility plans would be ready for review in a couple of weeks along with setting the bid date and presenting the final cost of the project. Schechinger added that site plans were continually being reviewed as submitted for residential homes.

COMMENTS FROM MAYOR AND COUNCIL MEMBERS

Laughlin asked the Council what the wanted to do with the ARPA Funds received in August from the federal government. Kofoed reminded the Council that there are specific rules for how the dollars can be spent and suggested that they keep those dollars in mind for the waste water treatment facility or the East side water main project. Laughlin reminded the Council of the budget work session meeting scheduled for 5:30 p.m. on Monday, January 10th.



ORDINANCE 789

AN ORDINANCE AMENDING TITLE "TRAFFIC AND VEHICLES" CHAPTER 69 "PARKING REGULATIONS".

<u>Section 1: Amendment.</u> The Code of Ordinances is hereby amended by the City Council of West Branch, Iowa by adding the following new subsections to Title, "TRAFFIC AND VEHICLES", Chapter 69, "PARKING REGULATIONS", Section 69.08, NO PARKING ZONES.

<u>Section 2. Conflicts.</u> All ordinances or parts of ordinances not specifically provided for and in conflict with the provisions of this ordinance are hereby repealed.

<u>Section 3. Adjudication.</u> If any section, provision, or part of this ordinance shall be adjudged to be invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

<u>Section 4. Effective Date.</u> This ordinance shall be in full force and effect after its passage, approval and publication as required by law.

any ordinance amending the official zoning map, establishing building lines, establishing and changing grades, or dedicating property for public use; nor shall it affect any prosecution, suit or other proceeding pending or any judgment rendered on or prior to the effective date of this ordinance.

SECTION 5. The following ordinances, passed subsequent to the preparation of this code but prior to adoption of this code, are hereby adopted and made a part of this code.

SECTION 6. An official copy of the "CODE OF ORDINANCES OF THE CITY OF WEST BRANCH, IOWA," adopted by this ordinance, including a certificate of the City Clerk as to its adoption and the effective date, is on file in the office of the City Clerk, and shall be kept available for public inspection.

SECTION 7. The City Clerk shall furnish a copy of the "CODE OF ORDINANCES OF THE CITY OF WEST BRANCH, IOWA," to the Judicial Magistrates serving the City of West Branch.

SECTION 8. This ordinance shall be in full force and effect from and after the publication of this ordinance, as required by law.

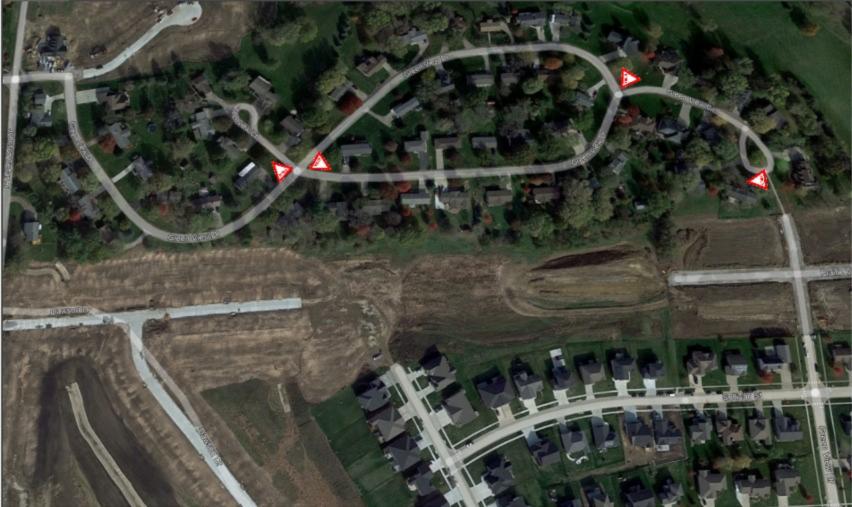

ORDINANCE 790

AN ORDINANCE AMENDING TITLE "TRAFFIC AND VEHICLES" CHAPTER 65 "STOP OR YIELD REQUIRED".

WHEREAS, the West Branch City Council finds it in the best interest of the residents of West Branch to have yield signs installed on Cookson Drive at its intersection with South First Street, on Greenview Court at its intersection with Greenview Drive, on Greenview Drive, on Greenview Drive southern loop westbound lane at its intersection with Greenview Drive, on Greenview Circle at its intersection with Greenview Drive and the southbound portion of the traffic circle on Greenview Circle at its intersection with Greenview Drive in order to provide for the safety of the West Branch Community.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of West Branch, Cedar County, Iowa:

<u>Section 1: Amendment.</u> The Code of Ordinances is hereby amended by the City Council of West Branch, Iowa by adding the following new subsections to Title, "TRAFFIC AND VEHICLES", Chapter 65, "STOP OR YIELD REQUIRED", Section 65.03, YIELD REQUIRED.

<u>Section 3. Adjudication.</u> If any section, provision, or part of this ordinance shall be adjudged to be invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

<u>Section 4. Effective Date.</u> This ordinance shall be in full force and effect after its passage, approval and publication as required by law.
